INSTRUCTIONS

I.WHERE TO APPLY

Application forms (in duplicate) shall be secured from the BAI-Animal Health and Welfare Division (AHWD), Visayas Avenue, Diliman, Quezon City or from any DA-Regional Field Offices. The accomplished form together with all supporting documents shall be filed at the office of the Chief, BAI-AHWD for recording, evaluation, processing and assignment of accreditation number.

II.DOCUMENTS REQUIRED

ID picture of the Owner/General Manager and Veterinarian
PRC License and PTR (Photocopy)
Location Plan/Sketch of the Establishment
Certification/s that the veterinarian has attended seminar/s on Animal Welfare
Duly filled-up Agreement Fee
Payment of Accreditation Fee

III. DISPLAY OF ACCREDITATION CERTIFICATE

Registration Certificate shall be displayed conspicuously in the place of business and must be readily visible to the public.

IV. VALIDITY OF ACCREDITATION

Accreditation is valid for one (1) year only and is renewable annually.

V. SURCHARGE: A surcharge shall be levied on every expired Accreditation
