BAC RESOLUTION RECOMMENDING FOR AWARD

Resolution No. **23-860**
 Series of 2023

WHEREAS, Purchase Request No. **AFVDBCD LPF 2023-09-041** for the **AFVDBCD Retooling and Planning Workshop in the "Implementation of the Republic Act 1556 or The Livestock and Poultry Feeds Act"** to be conducted on **December 18-19, 2023** at the **University of the Philippines Los Baños (UPLB) Laguna** was approved to change the mode of procurement from n/a to Lease of Venue;

WHEREAS, Annex "H" of the 2016 Revised IRR states that: **LEASE OF REAL PROPERTY AND VENUE** is a procurement covering lease of real property and venue for official use, where:

- a. i. xxx
- ii. Venue refers to training centers, convention halls, hotels, and similar establishments catering to trainings, seminars, conferences, conventions, symposia and similar gatherings requiring the official participation of government officials and employees. This may include meals and accommodation depending on the requirements of the Procuring Entity.

b. Policy Considerations

- i. Publicly-owned vis-a-vis privately-owned real property and venue
 It is preferred that government agencies lease publicly-owned real property or venue from other government agencies.
 If there is an available publicly-owned real property or venue that complies with the requirements of the Procuring Entity, it may enter into a contract of lease with the government-agency owner.

WHEREAS, the end-user conducted Market Survey within the area for the venue and requested for quotation;

NOW THEREFORE, in view of the foregoing premises, **THE COMMITTEE RESOLVES, AS IT IS HEREBY RESOLVED**, to recommend to the Head of the Procuring Entity to Award the Contract to **BOY SCOUTS OF THE PHILIPPINES, BP International Makiling** as the Single Calculated Responsive Bid for the above-mentioned request in the amount of **One Hundred Sixty Thousand Pesos (P 160,000.00)** only.
