Supply and delivery of 1 unit laboratory steam sterilizer a. What do you mean by delayed start function with real time allows the users to find their samples sterilized when they arrive to the laboratory in the morning so they do not loose time waiting for the sterilization of their samples?	It was agreed to remove this line
b. Can we change the line the microprocessor control systems have a comprehensive self-diagnostic system for providing information regarding system malfunctions?	It was agreed to change to it must have comprehensive self-diagnostic system.
 c. Can we offer bigger chamber volume? d. The preset programs are for what kind of 2 liquids and 3 solids? e. Can we remove the timer for free programs: 1-300 minutes? f. What is the real power consumption? g. Can the delivery period be increased? 	The chamber volume will be minimum of 40 liters The two (2) liquids are culture media and reagents while the three (3) solids are glass wares, syringes and autoclavable canisters It was agreed to remove this line. The power consumption is 2,500W and not 250 00W. The delivery period will be from 30 to 90 days. You can also deliver the goods within the specified period.
