BAC RESOLUTION RECOMMENDING FOR AWARD

WHEREAS, Purchase Request No. **ASF-2022-01-008** for the **supply and delivery of five hundred (500) pieces Interfolded towel, 175 pulls and thirty (30) cases Kim wipes delicate task wipes, 14.7" x 16.6", 15 box/case** was approved in the Annual Procurement Plan CY 2022 for Shopping;

WHEREAS, Annex "H" of the 2016 Revised IRR states that "Shopping is a method of procurement of goods whereby the Procuring Entity simply requests for the submission of price quotations for readily available off-the shelf goods or ordinary / regular equipment to procured directly from ;suppliers of known qualifications";

WHEREAS, the request was posted in the PhilGEPS on January 05, 2022 until its closing date on January 10, 2022 at 4:00 P.M. for Shopping;

WHEREAS, ten (10) suppliers submitted its bid proposal for the above-mentioned request;

WHEREAS, Abstract of Quotations was prepared and was referred to the Technical Working Group (TWG) and End-user for evaluation;

WHEREAS, the report containing the results of the TWG's evaluation is attached and marked hereto as Annex "B" and made an integral part hereof;

WHEREAS, the 1st, 2nd, and 3rd bidders namely: **TEBEMINI CORPORATION, NOVEAULAB ASIA CORPORATION AND JUST-IN-ONE MARKETING** did not comply with the end-user's specifications;

WHEREAS, after the review of the aforementioned findings of the TWG, the Committee resolved to adopt the same and recommend the Award of Contract to **MARABE ENTERPRISES** as the Lowest Calculated Responsive Bid;

NOW THEREFORE, in view of the foregoing premises, **THE COMMITTEE RESOLVES, AS IT IS HEREBY RESOLVED**, to recommend to the Head of the Procuring Entity to Award the Contract to **MARABE ENTERPRISES** as the Lowest Calculated Responsive Bid for the above-mentioned request in the amount of **Two Hundred One Thousand One Hundred Pesos (P 201,100.00)** only.
