II. Application Fee

INITIAL (One Year): PHP 100.00

RENEWAL (Three Years): PHP 300.00

Surcharge Fee: Upon renewal, a surcharge of 50% of the amount due shall be levied on every expired registration certificate.

Pursuant to the provisions of RA 8485, otherwise known as The Animal Welfare Act of 1998, as amended by RA10631, Its Revised Implementing Rules and Regulations and related Department of Agriculture Administrative Issuances. the CERTIFICATE OF REGISTRATION as Animal-Event Organizer, shall be issued by the Bureau of Animal Industry upon proof that the organizer is compliant with the aforementioned laws, rules and regulations.
