SUBJECT : GUIDANCE IN THE PROCESSING OF LOCAL SHIPPING PERMIT APPLICATIONS FOR MARCH 6 to 8, 2025

To ensure service continuity and promote the unhampered delivery of live animals, animal products, and by-products during times of urgency, due to the internet and system outages, we direct all clients **to apply directly at the Veterinary Quarantine Stations (VQS) or NVQSD Central Office (NVQSD-CO) for the issuance of manual local shipping permits from March 6 to 8, 2025.** All applications will be processed during working hours **8:00 AM to 5:00 PM.**

Throughout this period, **VQS 3 and VQS 4A will maintain extended service hours, operating from 8:00 AM to 10:00 PM,** to ensure efficient processing of all applications.

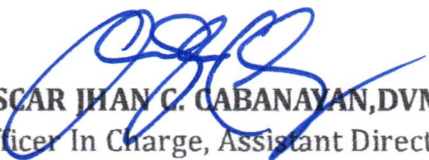
