**BAC RESOLUTION RECOMMENDING FOR AWARD**  
Resolution No. **23-198**

**WHEREAS**, Purchase Request No. **FS 2023-01-014** for the **supply and delivery of Indirect multi-species ELISA kits for Toxoplasma and Trichinella antibodies and Positive and Negative Freeze-Dried Antibodies Reference Serum** was approved to change the mode of procurement from Small Value Procurement to Direct Contracting as per BAC Resolution No.: 23-125;
