MEMORANDUM CIRCULAR

SUBJECT:

UPDATED LIST OF ACCREDITED COUNTRIES (SYSTEM /INDIVIDUAL/

TRADITIONAL) SOURCES OF LIVE ANIMALS FOR EXPORT TO THE

PHILIPPINES.

WHEREAS, the strengthening of our country's importation amidst enhanced world trade liberalization requires a strengthened regulation and services to prevent the entry of exotic diseases and spread of endemic diseases into the country;

WHEREAS, pursuant to DA Memorandum Circular no. 12, series of 2017, entitled 'Importation Procedures for Live Animals into the Philippines', prescribes that the Bureau of Animal Industry as the competent authority responsible to accredit and compliance of animal establishments and feed plants/manufacturers into the Philippine;

WHEREAS, by the virtue of BAI Special Order no.251, the BAI Pre-Inspection and Accreditation Review Committee (BAI-PARC) for Live Animals, Animal Feeds, Veterinary Drugs and Biologics unanimously recommended and affirms the revalidation and recognition of traditional sources for live horses and live birds (PARC Resolution no. 1);

NOW THEREFORE. Updated here the list Accredited countries (System/Individual/Traditional) as sources of Live Animals for Export to Philippines as of 1 March 2024.
