Sealed bids in triplicate copies for the sale of **Ninety (90) head culled cattle** shall be received by the Bureau of Animal Industry (BAI) Committee on Livestock Disposal at **National Beef Cattle Research and Development Center I (NBCRDC-I)** located in Coron at **10:00 A.M.** at which date, time and place the bids will be opened in the presence of the bidders or their duly authorized representative.

DESCRIPTION OF CATTLE FOR SALE

90 hd Culled Cattle

TERMS AND CONDITIONS OF SALE

1. The **Ninety (90) hd Culled Cattle** can be sold on a **PER KILO LIVEWEIGHT, AS IS, WHERE IS BASIS, EX-FARM**, National Beef Cattle Research and Development Center I (NBCRDC- I) , located in Sitio Tulbuan Barangay Decalachao, Coron, Palawan with estimated total of **27,204 kgs.** at **P85.00/kg** live weight and above.
2. The interested bidders may secure Quotation Forms at BAI - Property Unit, Visayas Avenue Diliman, Quezon City or at the NBCRDC- I, Coron, Palawan upon presentation of the following documents:
 - a) Valid Identification Card;
 - b) Certified Photocopy of Municipal License/Business Permits, and
 - c) Special Power of Attorney for those authorized representative.

And are presumed to have seen and inspected the above described cattle for sale at the place where the same are located.

3. Each bid shall state the price offered per kilo live weight. The bid tendered shall be accompanied by a Bid Bond in cash or Manager's Check, equivalent to 10% of the total amount offered to guarantee the bid. In the case of the winning bidder, the 10% Bid Bond shall be converted as down payment. In the case of non-winning bidders, the 10% Bid Bond shall be returned. Violation by any bidder of the terms and conditions of the sale, the 10% Bid Bond shall be forfeited in favor of the BAI.
4. All offers shall be stated in words and in figures. In case of discrepancy, the amount most advantageous to the government shall prevail. Participating bidders are required to personally drop their offer together with their Bid Bond in cash equivalent to 10% of the amount offered in a sealed envelope, in the drop box located in the BAI-OD Conference Room.
5. After all the bids submitted had been opened by the Committee, the sealed envelope containing the floor price per kilo live weight set by the agency head shall be exhibited to the participating bidders for their information. The bid that matches the floor price or higher shall be declared the winning bidder.

6. The Committee on Animal Disposal, together with the Winning Bidder or his/her duly authorized representative, upon agreement of a particular date, shall conduct the actual weighing of the subject cattle to determine its total kilo live weight. After the actual weighing, the Winning Bidder shall pay in cash to the Cashier Unit – Bureau of Animal Industry, Visayas Avenue, Diliman, Quezon City, the total amount based on the per kilo live weight offered in the bid. Failure on the part of the Winning Bidder to effect payment as herein provided shall lead to the cancellation of the Bid and forfeiture of the 10% Cash Bid Bond in favor of the Bureau of Animal Industry.
7. The Bureau of Animal Industry, upon receipt of the full payment in cash from the Winning Bidder for the above mentioned animals shall issue the Award and a writted Authority to Release addressed to the Center Chief of NBCRDC-I, Coron, Palawan.
8. It is understood that the handling, transportation, including all incidental expenses that may arise in the withdrawal of these cattle from the NBCRDC-I, Coron, Palawan are solely for the account of the Awardee.
9. The Awardee hereby agrees and binds himself/herself to withdraw the Ninety (90) hd culled cattle from the NBCRDC –I, Coron Palawan within three (3) days from the receipt of a copy of the written Authority to Release issued by the Director, Bureau of Animal Industry. Failure on the part of the Awardee to withdraw the subject animals sold to him/her, within the prescribed period, the Bureau of Animal Industry, shall in no way be held liable by the Awardee for any deaths and/or losses that the Awardee may incur/suffer by reason of his/her failure to comply with this condition.
10. The Committee on Animal Disposal reserved the right to reject any or all bids without offering any reason, and shall accept the offer/quotation most advantageous to the government.
