**MEMORANDUM ORDER**

**SUBJECT: TEMPORARY BAN ON THE IMPORTATION OF DOMESTIC AND WILD BIRDS AND THEIR PRODUCTS INCLUDING POULTRY MEAT, DAY OLD CHICKS, EGGS AND SEMEN ORIGINATING FROM Netherlands;**

**WHEREAS**, Section 6 and 7 (2) and (4) of Executive Order no. 291 provides the authority and responsibility for the exercise of the mandate of the Department and for the discharge of its powers and functions shall be vested in the Secretary, who shall have supervision and control of the Department pursuant to the approved programs of government and promulgate administrative issuances necessary for the efficient administration of the offices under the Secretary and the proper execution of the laws relative thereto;

**WHEREAS**, Section 1770 of Act No. 2711 (Revised Administrative Code of 1917) which was adopted by incorporation together with Sections 1761-1769, in Section 5 of Act 3639 (Charter of BAI) empowers the Department Head to issue a general order preventing the entry of animals, animal effects, parts or products from any country with dangerous communicable animal disease;

**WHEREAS**, based on the report of the Chief Veterinary Officer, Agriculture, Nature and Food Quality, Ministry of Agriculture, Nature and Food Quality, The Hague, Netherlands, to the World Organisation for Animal Health (OIE) on October 28, 2021, that there was an outbreak of H5N1 Highly Pathogenic Avian Influenza in Zeewolde, Flevoland, Netherlands;


**WHEREAS**, there is a need to prevent the entry of HPAI virus to protect the health of the local poultry population;

**NOW, THEREFORE, I, WILLIAM D. DAR**, Secretary of the Department of Agriculture, by the powers vested in me by law, do hereby institute the following emergency measures for the importation of wild birds and their products from Netherlands;

1. Banning the importation of domestic and wild birds and their products, including poultry meat, day old chicks, eggs and semen;
2. Immediate suspension of the processing, evaluation of the application and issuance of Sanitary and Phytosanitary (SPS) import clearance to the above stated commodities;
3. All shipments IN TRANSIT/LOADED/ACCEPTED UNTO PORT before the official communication of this Order to the Dutch authorities shall be allowed provided the products were slaughtered/produced before October 13, 2021;
4. All other shipments accepted at the port of origin the day after the date of the official communication to the Dutch authorities are therefore advised not to sail;
5. Shipments which have not complied with the conditions set forth in Item 3 to Item 4 shall be dealt with as per DA AO 9 S. 2010 Section VII.D;
6. Importation of meat products of poultry is subject to the conditions provided in Article 10.4.18, 10.4.19 and 10.4.24 of OIE Terrestrial Animal Health Code (2021)

This **ORDER** shall take effect immediately.
