SUBJECT: GUIDELINES IN THE ISSUANCE OF SHOW CAUSE ORDER FOR LOCAL SHIPMENT

VIOLATIONS

To facilitate the immediate issuance of BAI Show Cause Order relative to local shipment violations such as the falsification of shipment documents as provided in BAI Memorandum Circular No. 23 s.2020, the following guidelines are hereby issued, for the guidance of all concerned:

- 1. The Show Cause Order is issued for local shipment violations listed in Section 8 of DA Administrative Order No. 5 s.2019 as part of the due process.
- 2. The Regional Veterinary Quarantine Officer/Chief of Veterinary Quarantine Station will prepare and issue the Show Cause Order for reported shipment violations in its area of jurisdiction using the attached template in Annex 1;
- 3. Reports should be supported by a written Incident Report (IR) from BAI-VQS or LGU, preferably following the IR template provided in BAI Memorandum Order No. 18 s.2020;
- 4. The Show Cause Order should be sent to the shipper concerned by means of his/her electronic mail address (preferred); registered mail to a physical address; or via the complainant LGU office.
- 5. The scanned copy of Show Cause Order shall be submitted electronically by the RVQO to the NVQSD Central Office and the Office of the BAI Director;
- 6. All written explanations/answers of the respondent should be verified and submitted via official email address: directorrdd@bai.gov.ph and nvqsd@bai.gov.ph, copy furnish the Veterinary Quarantine Station, for legal review and advise on the final resolution of the case. The BAI will decide on the case within ninety (90) days from its receipt.
- 7. The shipper retains the original copy of the notarized written statement for future reference.

Please be informed that the presentation of Tampered, Recycled or Fake documentation ar

Please be informed that the presentation of Tampered, Recycled or Fake documentation and Misdeclarations in the shipment were in violation of Section 8 of DA Administrative Order No.5 s.2019. Falsification of the Veterinary Health Certificate and Shipping Permit is a serious offense under BAI Memorandum Circular No. 23 of 08 June 2020 and other regulations.

In view of the above, you are hereby given **THREE ( 3) DAYS** from receipt of this notice to submit a verified answer and SHOW CAUSE why we should not permanently revoke or cancel *the BAI-NVQSD-Online Local Shipping Permit Issuance System account used in this transaction (For Online SP application violation)*, blacklist your name, revoke or cancel the BAI Transport Carrier Registration and Livestock Handlers License and take legal action against you for having falsified shipping documents.
