MEMORANDUM ORDER

SUBJECT: AMENDMENT TO MEMORANDUM ORDER NO. 23 SERIES OF 2016, "ENTERPRISE DEVELOPMENT THROUGH THE ESTABLISHMENT OF SUSTAINABLE LIVESTOCK AND POULTRY MULTIPLIER FARMS" INCORPORATING HERewith RELEVANT IMPLEMENTING RULES AND GUIDELINES FOR THE "LIVESTOCK ENTERPRISE AND ECONOMIC DEVELOPMENT PROGRAM" ALSO KNOWN AS LEED PROGRAM

In the interest of the service and to further facilitate continuous implementation of the Memorandum Order No. 23 Series of 2016, and to include and incorporate relevant guidelines for the implementation of the LEED Program, implementing units or agencies shall be guided by the following amendments:

PART I. OBJECTIVE, is hereby revised to read as follows:

The objective of the Multiplier Farms Project (MFP) is to establish breeding farms in strategic areas of the country, producing genetically superior breeder animals for distribution to qualified individuals or groups for livelihood and/or enterprise development.

PART III. DESCRIPTION OF THE PROJECT, is hereby revised to read as follows:

Under the Project, the Department of Agriculture-Regional Field Offices (DA-RFOs) shall, with its eligible partner/s, establish Multiplier Farms (MFs) in strategic areas of the country. These MFs shall acquire and keep breeder animals which shall be bred to produce genetically-superior offsprings for distribution to qualified individual farmers and/or farmer groups.

Based on the carrying capacity and approved budgetary allocation, a Multiplier farm shall have at least one (1) module of any of the following commodities:

1. Goat module
2. Sheep module
3. Native chicken module
4. Native pig module
5. Duck (Itik-Pinas) module
6. Rabbit module
7. Honeybee module
8. Cattle module
9. Carabao module

PART V. ELIGIBILITY is hereby revised to read as follows:

PART VI. MECHANICS OF IMPLEMENTATION, is hereby amended to read as follows:

Item No. 2. *A MF is characterized by having ANY of the following Modules: goat, sheep, native chicken, native pig, duck (Itik-Pinas), rabbit, honeybee, cattle, and carabao;*

Item No. 4. *Implementing Partner shall comply to all documentary requirements to qualify in the selection process of the DA-RFO*

PART IX. EFFECTIVITY, is hereby revised to read as follows:

All other provisions in Memorandum Order No. 23 Series of 2016 shall remain in order. Furthermore, Memorandum Order No. 23, Series of 2016 and its Amendments, where applicable, shall cover and shall form part of the implementing guidelines for the LEED Program.

This Memorandum Order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and other issuances inconsistent herewith are deemed revoked.
