**BAC RESOLUTION RECOMMENDING FOR AWARD**

Resolution No. 22-438

**WHEREAS**, Purchase Request No. **VLD FS 2022-05-110** for the **supply and delivery of various sizes of single channel pipettors** was approved in the Annual Procurement Plan CY 2022 for Small Value Procurement;

**WHEREAS**, RULE XVI – Alternative Methods of Procurement, Section 53.9 Small Value Procurement is procurement of goods, infrastructure and consulting services, where the amount involved does not exceed the threshold prescribed in Annex “H” of 2016 Revised IRR: *Provided*, that in case of Goods, the procurement does not fall under Shopping in Section 52 of this IRR”;

**WHEREAS**, the request was posted in PhilGEPS on May 26, 2022 until its closing date on May 31, 2022 at 4:00 P.M. for Small Value Procurement;

**WHEREAS**, six (6) invitations were sent to prospective suppliers of known technical, legal and financial qualification to supply and deliver goods which are the following;

2. Labotech Trading
3. Labtraders Inc.
4. Scientific Biotech Specialties Inc.

6. Glenwood Technologies International, Inc.

**WHEREAS**, in response to the invitation and PhilGEPS posting, eleven (11) suppliers submitted its bid proposals for the above-mentioned request;

**WHEREAS**, Abstract of Quotations was prepared and was referred to the Technical Working Group (TWG) and End-user for evaluation;

**WHEREAS**, the report containing the results of the TWG evaluation is attached and marked hereto as Annex “B” and made an integral part hereof;

**WHEREAS**, after the review of the aforementioned findings of the TWG, the Committee resolved to adopt the same and recommend the Award of Contract to **DKSH PHILIPPINES, INC.**, as the Lowest Calculated Responsive Bid;

**NOW THEREFORE**, in view of the foregoing premises, **THE COMMITTEE RESOLVES, AS IT IS HEREBY RESOLVED**, to recommend to the Head of the Procuring Entity to Award the Contract to **DKSH PHILIPPINES, INC.**, as the Lowest Calculated Responsive Bid for the above-mentioned request in the amount of **Two Hundred Forty-Five Thousand Three Hundred Fifty Pesos (P 245,350.00)** only.
