What is eVHC?

A DIGITAL DOCUMENT ISSUED BY A LICENSED VETERINARIAN TO CERTIFY THE HEALTH STATUS OF ANIMALS FOR PURPOSES SUCH AS TRANSPORT, SALE, OR EXPORT.

Introduction

Veterinarian Registration Information System (VRIS)

This system was designed to manage the registration process for licensed veterinarians in both the government and private sectors.

It enables them to track their professional information, credentials, practice details, and compliance with continuing education requirements, ensuring proper regulation and oversight of veterinary practice within a region.

The system typically includes features for application submission, issuance of veterinary health certificate and management.

Electronic Veterinary Health Certificate (eVHC)

A licensed veterinarian issues a digital document to certify the health status of animals for purposes such as transport, sale, or export.

It streamlines the traditional paper-based process, ensuring faster issuance, improved traceability, and enhanced data accuracy.

The eVHC includes critical information such as animal identification, health assessments, vaccination records, and compliance with regulatory requirements. By leveraging digital tools, it supports better disease monitoring, facilitates regulatory compliance, and promotes animal welfare and public health.



Website Registration Process Flow

Client Registration

Business Account – This applies to entities such as Corporation, Partnership, Single/Sole Proprietorship and Cooperative.

- Services offered under a Business Account include:
 - Facility Registration
 - > Transport Carrier Accreditation
 - > Local Shipping Permit Issuance

 - Private Veterinarian Registration and Electronic Veterinary Health Certificate (eVHC)

Non-Business Account – This category includes individuals and entities such as Pet Owner's, Smallholder, Association, Private Universities/Colleges, Non-Government Organization, Handlers, Private Veterinarians and Job Applicants.

2.2. Evaluation and Approval

If your registration is declined, the status will be updated accordingly, and the administrator's comments will be displayed. (See sample image below)



Once you have complied with the requirements, click the **Submit** button again to resubmit your registration.

Upon approval of your registration, a "Verified" status will appear in your veterinarian profile. (See image below)
